

## **JAMES' GUIDANCE ON COMPLETING PART B OF THE NATIONWIDE FORM**

- 1. Please enter your FULL name (i.e including middle names), FULL address and the post code on Part B of the form.**

These details will be verified against Nationwide's records to identify that you are an eligible customer / member. Nationwide will likely reject forms that don't include your full name and full address i.e. these need to match what Nationwide has on record.

- 2. Your "share account number" is your current / savings account details (i.e. the 8 digit account number assigned to you by Nationwide). Alternatively you can provide your 10-11 digit mortgage account number if relevant.**

These details are not mandatory to be an eligible and valid nomination, but Nationwide has requested these are added if possible to speed up the verification process. See the notes at the end of this document for more information.

- 3. Please add your signature to Part B so that it matches Nationwide's records.**

If Part B is unsigned, or the signature does not match, your nomination is unlikely to be accepted by Nationwide. Your signature on the form does not need to be a "wet ink" signature - e.g. it can be a scanned image of your signature - but it does need to closely resemble the signature the society has on file for you.

- 4. Please add the date of when you sign the form.**

Undated forms are unlikely to be accepted by Nationwide. Forms need to be dated within the current financial year which runs from 1 April 2025 to 31 March 2026.

- 5. Please return PART B ONLY of the completed form to me.**

Nationwide has requested nominations are collected by me and delivered in a batch.

- YOU ONLY NEED TO RETURN PART B, scanned or photographed, to [nominate@james4nationwide.co.uk](mailto:nominate@james4nationwide.co.uk). Alternatively, you can post PART B to my address given in Part A.
- IF YOU DON'T HAVE A PRINTER / CAN'T ADD YOUR SIGNATURE
  - Sign a white piece of paper (that matches what the society has on file), take a photo with a smart phone and email it to me. I will then add it to your form and email the completed form to you to verify, OR
  - Ask a friend or family member to print the form and email it to me, OR
  - If requested, I will post you a form to complete & return by post.

## **Nationwide's accompanying notes**

1. The nomination of a candidate for election as a director may be made by 250 "qualified two year" members.
2. A member is a "qualified two year" member if the member:
  - a. is at least 18 years of age at the date on which Nationwide Building Society (the "Society") receives the nomination; and
  - b. held a share investment with the Society with a value of at least £200 throughout the period of two years ending on the date on which the Society receives the nomination; or
  - c. owed the Society at least £200 on a mortgage loan throughout the period of two years ending on the date on which the Society receives the nomination.
3. Each nominating member should provide in Part B all share or mortgage loan account numbers necessary to show that he/she has been a "qualified two year" member throughout the continuous two year period specified. This may require providing more than one account number where different accounts have been held throughout the period. Failure to provide the relevant information may result in the form being rejected as invalid.
4. Each nominating member must provide their full name and address (including postcode) for the purposes of identification. Failure to provide full details may result in the form being rejected as invalid.
5. In the case of joint members, only the first named joint member may join the nomination.
6. Nominating members are not required to sign the same physical document.
